- Regulation 513/2014 establishing, as part of the Internal Security Fund, the instrument for financial support for police cooperation, preventing and combating crime, and crisis management;
- Regulation 516/2014 establishing the Asylum, Migration and Integration Fund.
- 16.30: Migration and asylum: Expulsions/Administrative Decisions/Monitoring of forced return under Returns Directive and/or as the OPCAT body/Children's rights/Family reunification/Visas for third country family members.

- Council Directive 2003/86/EC on the right to family reunification;
- Directive 2004/38/EC on the right of citizens of the Union and their family members to move freely within the territory of the Member States.
