The Portuguese Ombudsman' parliamentary hearing

On June 14th the Portuguese Ombudsman was heard in the Committee on Constitutional Affairs, Rights, Freedoms and Guarantees regarding the 2016 Report to the Parliament presented to the Parliament President.







The Portuguese Ombudsman traditional activity

The development of the Portuguese Ombudsman traditional activity is mainly substantiated by procedures that comes from citizen's complaints or are open by its own initiative, instructed and analyzed every day.

Constitutional Court ruled on the petition presented by the Portuguese Ombudsman

The Constitutional Court, through the Decree No. 244/2017, of May 17, 2017, claimed not to know the subject of the request for the successive abstract supervision formulated by the Portuguese Ombudsman, motivated by the amendment of the Law No. 40-A/2016, of December 22nd. This change was convergent with the concerns that dictated the initiative of this body of State.

The Portuguese Ombudsman defends the rights of banned or expelled clients from accessing casinos

The Secretary of State for Tourism is committed to strengthen, in the context of the revision of the Gaming Law, the rights recognized to casino clients who are expelled or forbidden to enter the casinos.

In the context of the examination of a complaint, the Portuguese Ombudsman concluded that the right to information and the right of defense of those who were expelled or banned from entering the casinos were not adequately guaranteed.

During the revision process, the Lisbon's City Hall undertook the task of amending the norms of the Municipal Plan

The Portuguese Ombudsman's Recommendation No. 5/A/2016 addressed to the Lisbon City Hall was partially accepted.

As a response to the Recommendation, the City Hall recognized that it is necessary to ensure the clarity, rigor and objectivity of the Municipal Plan norms. The criteria will be added into the norms, in a way they are not too abstract or uncertain, in order to guarantee the predictability of their application and the confidence of the citizens. The City Hall also recognized the insufficiency of parking places in the area of the Museum of Art, Architecture and Technology, and reported that there are efforts being made to reduce this problem.





The Portuguese Ombudsman, prisons and the 21st century: visits diary

Last year the Portuguese Ombudsman started to visit the Portuguese prisons under the project *The Portuguese Ombudsman, prisons and the 21st century: visits diary.* In this newsletter timeframe, the Portuguese Ombudsman published four visit reports, visited personally by the Ombudsman and without previous notice: the *Tomar Military Prison* (December 7th), *São João de Deus Prison* (January 17th), *Pinheiro da Cruz Prison* (March 15th) and the *Oporto Prison* (April 20th).

The citizens can monitor this project throughout the reports available in the institutional website.

This project ended with the conference *As prisões e o século XXI*, held on June 7th, with the support of the Calouste Gulbenkian Foundation.

The Portuguese Ombudsman as National Human Rights Institution

Commemorative dates

As National Human Rights Institution, the Portuguese Ombudsman points out, through various initiatives and messages available on its institutional website, some evocative dates. Within this newsletter' timeframe were celebrated the following dates: *World Day for Cultural Diversity for Dialogue and Development* (May 19th), *World Children's Day* (June 1st), *World Day Against Child Labour* (June 12th), *World Elder Abuse Awareness Day* (June 14th), *World Refugee Day* (June 20th) and the *International Day in Support of Victims of Torture* (June 26th).

Other messages from the Portuguese Ombudsman

On June 19th the Portuguese Ombudsman, in a message published on the institutional website and Facebook page, expressed its deep regret for the tragedy of *Pedrogão Grande*. Joining the President of the Parliament solidarity gesture, the Ombudsman honored, with a minute's silence, the fire victims.

The Portuguese Ombudsman as the National Preventive Mechanism Visits

The *National Preventive Mechanism* (NPM) made four visits to educational centers and a court.





Recommendations

Within this timeframe were issued two recommendations, one addressed to the Director Manager of the São José Psychiatric Clinic (recommendation 12) and the other to the President of the Administration of the Baixo Alentejo Health Local Unit (recommendation 13).

The NPM' recommendation 5, issued on February 10th about the Castelo Branco Prison conditions, was welcomed.

Cooptation procedure for the Advisory Council

The NPM publicized the cooptation procedure for two civil society associations to integrate the Advisory Council. The NPM Advisory Council is a consultative body made up of representatives from the Committee on Constitutional Affairs, Rights, Freedoms and Guarantees, the Superior Councils of the Magistracy, the Public Prosecutor's Office, the Bar, Physicians and Psychologists Association, and by three individuals of high and recognized ethical and civic statutes.

This event was organized by one of the thematic networks of FIO, the *Red sobre Migrantes y Trata de Personas* and the National Human Rights Commission of Mexico, with the collaboration of the German Cooperation Agency ProFIO (GIZ).

International Seminar

On June 1st and 2nd, this body of State participated in the international seminar *Derecho a la ciudad y sustentabilidade. International cooperation activities

Twinning Project
